I. INTRODUCTION AND OBJECTIVE




Figure 1. Project Location and Potential Environmental Justice Area(s)

This Public Participation Plan (PPP) Report has been prepared by Wheelabrator Hudson Falls LLC (hereinafter referred to as "applicant") to fulfill and comply with the requirements of New York State Department of Environmental Conservation Commissioner Policy 29, Environmental Justice and Permitting (CP-29) for their proposed Title V Permit Modification that requires a Title V Permit application and which has been determined by NYSDEC to potentially impact one or more potential environmental justice area (PEJA) (See Figure 1).

The objective of this PPP Report is to outline and describe the program of activities that the applicant implemented to actively seek and enhance public participation during the application review process.

II. PROJECT DESCRIPTION AND PROPOSED ACTION

Project Overview

Wheelabrator Hudson Falls (WHF) submitted an application to modify and renew the Title V Operating Permit (TVOP) with a modification to reduce Nitrogen Oxides (NOx) emissions by 20% of its current permitted level. WHF is a waste-to-energy (WTE) facility that diverts waste from landfills and can convert up to 160,00 tons of waste from Warren County, Washington County and other communities into renewable electricity that powers the equivalent of more than 10,000 homes and businesses annually. WHF is located at 93 River Street, Hudson Falls, NY 12839 in Washington County.

Nature of Proposed Project/Action and Purpose

WHF is renewing and modifying its TVOP, which includes incorporating the requirements of 6 New York Codes, Rules and Regulations (NYCRR) Part 219-10, Reasonably Available Control Technology (RACT) NOx at Municipal and Private Solid Waste Incineration Units. These RACT requirements are part of the United States Environmental Protection Agency's (USEPA) approved New York State Implementation Plan to help the state achieve and maintain the National Ambient Air Quality Standard for ozone required by the Clean Air Act (CAA). The incorporation of the RACT requirements in the TVOP renewal will reduce the legal NOx limit from 205 parts per million (ppm) to 185 ppm per unit and a facility average of 165 ppm, thereby lowering permitted NOx emissions by over 20%.

The modification of the TVOP will allow WHF to continue to locally dispose of Warren, Washington County, and other surrounding municipalities' waste safely and reliably while reducing greenhouse gas emissions.

Every ton of waste processed by WHF reduces greenhouse gases by 1.2 tons by diverting waste from landfills, avoiding the truck traffic required to reach landfills, recycling thousands of tons of metals, and avoiding fossil fuels. The permit modification is required to be in compliance with the NOx RACT permit limits enacted by NYSDEC.




Figure 2. [Site Plan]

Potential Impacts

There are no potential impacts associated with the Title V renewal project. WHF will continue to operate in compliance with all current permit conditions and requirements. The new lower NOx limit from 205 parts per million (ppm) to 185 ppm per unit and a facility average of 165 ppm, thereby lowering annual facility NOx emissions by over 20% of its current permitted levels.

The current contact list was developed in consultation with NYSDEC by identifying stakeholders from the following categories: local government and elected officials; business owners, residents, and occupants; local civic, community, environmental and religious organizations; local news media; administrator/operator of any school or daycare that lives, works, and/or represents a neighborhood or community within our host community of Hudson Falls, NY.

WHF used this contact list to communicate and disseminate information about the proposed project/action and permit application review process to the affected community and stakeholders. At minimum, this includes the distribution of the written information and outreach materials described in Section V to inform the community about upcoming public meetings and opportunities for public participation.

The contact list was reviewed periodically and updated as appropriate throughout the permit application review process. WHF updated the contact list with new stakeholders identified during the public meetings. In addition, individuals and organizations were added to the contact list upon request.

Impacted residents and interested stakeholders were able to contact the project liaison listed above to provide input to the project team, discuss any issues or concerns and/or to ask questions or request information. The project liaison responded in a timely manner and in the manner appropriate to the question or information request received. The project liaison was responsible for tracking and documenting public input, inquiries, questions, and information requests received, along with responses provided.

V. PUBLIC OUTREACH ACTIVITIES

In compliance with the requirements of CP-29, WHF held public meetings to keep the public informed about the proposed action and the environmental permit review process. WHF prepared and distributed written information and materials, including a meeting notice and fact sheet for each meeting, to encourage dialogue and solicit input from interested stakeholders during the permit application review process.

In addition, the applicant developed a project website at winwastehudsonfalls.com. All public outreach materials and information were prepared and presented in an easy-to-read, understandable format, using plain language free of legal terminology and geared towards a non-technical audience.

Both public meeting notices and fact sheets were made available and disseminated in English. In addition, the public could have contacted the project liaison about the availability of language assistance and to request that the notice and fact sheet be translated into another language for comprehension by non-English speaking or limited proficiency stakeholders. WIN Waste also requested the Village to post the invitation to the in-person meeting on their website and social pages, and published an invite in local papers to announce the meetings.

Public Meetings

The virtual public meeting was held on August 8, 2024, at 6 p.m. via Microsoft Teams. During the meeting, WHF presented a brief overview of the project, including relevant background information, details on the permitting action, scope of work, schedule, and community impacts. The second part of the meeting included a question-and-answer portion where the floor was open for attendees to ask questions, make remarks, and/or express concerns. In addition, the following discussion points will be addressed:

 Provided an update on the permit application review process and identified outstanding application requirements and future milestones in the application review process.

- Made it clear that the meeting was being held prior to NYSDEC's permitting decision for the project/action.
- Identified the location of the online document repository and provided directions on how attendees may obtain and review materials relevant to the application, documents related to the meeting, and other public participation plan components.
- Provided contact information for the project liaison and announced procedures for how attendees may obtain answers to questions after the meeting has concluded, or request additional information by telephone, email, and in writing.

The in-person public meeting was held on April 16, 2025, at 6 p.m. at the Kingsbury Fire House at 3715 Burgoyne Ave, Hudson Falls, NY. During the meeting, WHF presented a brief overview of the project, including relevant background information, details on the permitting action, scope of work, schedule, and community impacts. The second part of the meeting included a question- and answer-portion where the floor was open for attendees to ask questions, make remarks, and/or express concerns. In addition, the following discussion points will be addressed:

- Provided an update on the permit application review process and identified outstanding application requirements and future milestones in the application review process.
- Made it clear that the meeting was being held prior to NYSDEC's permitting decision for the project/action.
- Identified the location of the online document repository and provided directions on how attendees may obtain and review materials relevant to the application, documents related to the meeting, and other public participation plan components.
- Provided contact information for the project liaison and announced procedures for how attendees may obtain answers to questions after the meeting has concluded, or request additional information by telephone, email, and in writing.

Attendance was recorded during the virtual meeting by logging the names of people entering the virtual meeting and at the in person meeting with a sign-in sheet. The applicant tracked the number of attendees for all meetings held during implementation of this PPP and, where feasible and applicable, identified any affiliation of participants and interests represented at the meeting. In addition, the applicant documented meeting notes or minutes, along with a record of comments and questions raised in the meeting and respective responses and answers provided.

Public Meeting Notice Preparation and Distribution

Information regarding the details of the virtual public meeting and how to participate via computer and/or telephone was contained in the reader-friendly meeting notice shown in Appendix B. The notice was prepared in English. Through this notice, the public was invited and encouraged to attend the virtual public meeting held August 8, 2024, at 6 p.m.

Two weeks in advance of the public virtual meeting a notice was published in The Post Star, Adirondack Daily Enterprise, and The Press Republican, which are newspapers printed, published, and distributed in Warren, Washington, Essex, and Franklin County. The notice for the in-person meeting was published in the Post Star and the Albany Times

Union. In addition, both public meeting notices were emailed or mailed to the stakeholders identified in the contact list in Appendix A at least two weeks prior to both public meetings.

Fact Sheet Preparation and Distribution

Factual information about the proposed project/action, including an overview, purpose statement, and potential impacts, was outlined in the reader-friendly fact sheet shown in Appendix C. In addition, the fact sheet outlined how interested stakeholders could participate in the permit application review process; access the online document repository to review relevant application materials prior to the public meeting; and contact the project team to obtain additional information. The fact sheet was prepared in English.

The fact sheet was posted and available in the online document repository described in Section VI of this document. No later than 2 weeks prior to the public meetings, WHF distributed the fact sheet to provide stakeholders with relevant background on the proposed project/action and facilitated meaningful participation during the meeting. The fact sheet was distributed together with the public meeting notice via email or mail.

VI. DOCUMENT REPOSITORY

An online document repository was established for the community and interested stakeholders to access and review information about the project. The online repository is available at www.winwastehudsonfalls.com/documents provides information and documents relating to the project and permit application.

The repository has been updated throughout the application process with project-related information and written materials (i.e., application forms and supporting materials, fact sheet).



 A Public Participation Plan (PPP) has been developed in accordance with NYSDEC Commissioner Policy 29, Environmental Justice and Permitting (CP-29)

What is the Proposed Project?

Wheelabrator Hudson Falls LLC (WHF) has submitted an application for a Title V Air Operating Permit (TVOP) modification to reduce Nitrogen Oxides (NOx) emissions by more than 18% of its current permitted level and renew the five-year TVOP. The TVOP permit renewal will incorporate the requirements of 6 New York Codes, Rules and Regulations Part 219-10, Reasonably Available Control Technology (RACT) NOx at Municipal and Private Solid Waste Incineration Units. WHF is a waste-to-energy (WTE) facility that diverts waste from landfills and instead, converts 150,000 tons of waste in Westchester County into renewable electricity that powers the equivalent of more than 10,000 homes and businesses annually. To implement the proposed project, WWLP has submitted an application for a Title V permit renewal to the NYSDEC to continue its essential operations and reduce emissions. The purpose of this fact sheet is to inform the public about the proposed project and involve the community during the NYSDEC permit application review process.

Why does Wheelabrator Hudson Falls LLC need to modity the Title V Air Permit?

The renewal of WHF's Title V air operating permit will allow WHF to continue to safely, reliably, and locally dispose of local waste while reducing greenhouse gas (GHG) emissions. Every ton of waste received at the facility eliminates approximately 1.2 tons GHG emission by diverting waste from landfills, avoiding the truck traffic required to reach them, recycling thousands of tons of metals and avoiding use of fossil fuels. WHF has been an essential component of Warren Washington County's sustainable waste ecosystem since it began in 1991 and has continuously achieved emissions levels well below state and federal standards. In addition, neighboring laundry facility White Plains Linen relies on WWLP to deliver steam to power its commercial laundry operations and reduce its use of natural gas. This permit modification will reduce WHF's NOx limit from 205 ppm to 185 ppm per unit and a facility average of 165 ppm, a more than 24% reduction.

How might the project affect the surrounding community?

There are no potential impacts associated with the Title V renewal project. WHF will continue to operate in compliance with all current permit conditions and requirements. The new lower NOx limit of 185 ppm per unit and a facility average of 165 ppm, a more than 20% reduction of its current permitted levels. Since 1991, WHF has continuously

achieved emission levels well below state and federal standards, and WHF will continue to operate without adverse impacts to air quality or the community.

APPENDIX D In-Person Meeting Summary (English)

Summary of Public Meeting on April 16, 2025:

On April 16, 2025, at 6 p.m., WIN Waste held an in-person public information meeting at the Kingsbury Volunteer Hose Company in Hudson Falls, which is a local venue commonly used for public meetings.

Two weeks before the meeting, WIN Waste sent out an invitation to the stakeholder list of ~500 postal addresses within the required .5 mile radius of the facility, and included a robust communication detailing our operations, information about our Title V application, the facility's actual emissions which are substantially lower than permitted levels, the types of waste materials taken in — how much and from where — as well as our commitment to safety, operational excellence, and the community we serve. For stakeholders who expressed interest in our project but did not provide us with a mailing address, we sent the same communication via email.

In addition, we placed public notice advertisements in two local newspapers (The Post-Star and the Albany Times Union), engaged in follow-up questions with local reporter(s), reached out to the Village of Hudson Falls who promoted our event on their Facebook page and website, and we also posted the meeting notice in the popular community Facebook group: Hudson Falls Open Forum (4,600+ members). WIN Waste also posted all relevant meeting documents to our document repository (www.winwastehudsonfalls.com).

During the meeting, which ran from 6 to 9 p.m., we had approximately 20 WIN Waste employees, NYSDEC representatives, and approximately 60 residents (representing Hudson Falls, Kingsbury, Fort Edward, Moreau, and South Glens Falls). WIN Waste had in attendance the Director of Air Quality and our Senior Director of Communications from our corporate office, our local operations team, and environmental compliance and safety teams.

The WIN Waste team presented information about our operations, air quality compliance, safety record, and our Title V permit application. During the meeting, WIN Waste chose to allow all residents to speak for as long as they had questions, as opposed to enforcing a time limit. Throughout the meeting, we heard many misconceptions and questions fueled by misinformation. WIN Waste recognizes the need to offer more opportunities to explain the facility operations and facts, as a majority of questions seemed to be rooted in misconceptions about the facility's performance records and strict local, state and federal regulations.

A majority of attendees did not speak, with approximately 20 individuals choosing to speak. Some attendees had questions and were interested in learning more about our operations, seeking a meaningful discussion. Others shared comments and sought additional information. Other speakers expressed opposition to the facility, advocating for zero emissions in their community and requesting that the facility be shut down and built elsewhere. The common themes, concerns, and confusion included desires for zero pollution, noted distrust in regulatory bodies and waste-to-energy operations, requests for more information and reporting, misinformation about natural gas use and energy efficiency, interest in DAC designation and Title V, concerns

about cancer rates, confusion around stack testing protocols, questions about the process with the DEC on any malfunctions, and questions around ambient air quality and emissions limits.

Common themes, concerns, and misconceptions discussed at the meeting:

Desire for Zero Pollution and Facility Opposition: Residents expressed a strong desire for zero pollution and voiced opposition to having any facility in their neighborhood and requested that the waste-to-energy facility be shut down and rebuilt in a different community. There was voiced concern and skepticism regarding the EPA and DEC's emissions safety standards and the overall safety of waste-to-energy operations.

Complaints of Odor from Glens Falls Biosolids Deliveries: Complaints about odor were linked to the delivery of biosolids from the Village of Glens Falls. WIN Waste was asked to take biosolids from Glens Falls when their disposal option closed. While we have reduced delivery frequency, we are committed to working with the Village of Glens Falls to further mitigate the odor.

Complaints of Noise from the Facility: The industrial facility generates noise, which has been a concern for residents. While some level of noise is unavoidable, we are committed to addressing these concerns through investments in targeted maintenance upgrades. This includes the replacement of a bypass valve and industrial silencers to reduce noise during steam venting or outages. Following the recent public meeting, we successfully replaced the bypass valve, which was a source of noise that was a concern.

Desire for More Information and Reporting: Residents want more frequent and detailed emissions reporting. We acknowledge this request and are committed to providing more information and increasing the frequency of emissions reporting.

Misinformation on Natural Gas Use and Energy Efficiency: There was misinformation given about the use of natural gas in the startup, shutdown and transient operations, and the efficiency of the facility's energy generation. WIN Waste will clarify the use of natural gas in the waste-to-energy process and provide accurate information to address these misconceptions.

Question about KPI's being linked to Safety and Environmental Compliance:

A resident requested WIN Waste describe the safety and environmental compliance KPI's for our daily operations and monitoring. WIN Waste explained that the number one priority for our company is safety, including the safety of our operations and surrounding communities. WIN Waste uses a reasonable inquiry process, and we track any environmental incidents over hours worked and these are reported to the highest level to WIN Waste leadership. WIN Waste will detail our safety and compliance programming in more detail for residents.

Interest in DAC Designation and Title V: Residents are interested in learning more about DAC designation and the timing of the comment period and hearing for Title V. WIN Waste will provide detailed information from the DEC on these topics to keep the community informed.

Cancer Rates in Surrounding Communities: There is significant misinformation regarding the cause of elevated cancer rates in the surrounding communities. WIN Waste will reference the recent New York State Department of Health Cancer Study, which detailed in its presentation that "Smoking, poor diet, obesity, and lack of physical activity are thought to be more important risk factors for some types of cancers." We will also provide the State's results that "...available data on outdoor air do not indicate an unusual impact of air

pollution on cancer incidence in Warren County in recent years." Source: https://www.health.ny.gov/diseases/cancer/docs/gcri_warren_2019_regional_meeting_final.pdf

Confusion Around Stack Testing Protocols: Residents want more information about stack testing protocols and the DEC's requirements for ensuring reliable and representative testing. WIN Waste will explain the DEC protocols in detail to ensure residents understand the reliability and representation of the testing.

Smoke Event at the Facility: There is interest in more information about a smoke event at the facility in 2024, and concern that the smoke was not processed through the stack and CEMS. We will clarify the DEC's review of malfunction protocols and provide detailed information to address these concerns.

Surrounding Ambient Air Quality and Emissions Limits: Residents would like more information from the DEC on emissions permit setting and evaluation. They would also like to understand the geography of the air monitors in use for monitoring air quality.

Next Steps: There were multiple requests for the open comment period information, and WIN Waste will provide that when the information is determined.




THE WASTE DISPOSAL CHALLENGE

New Yorkers are producing 40+ million tons of waste each year – more than ever before. Despite the state's leadership in recycling, New York is still generating more unrecyclable trash than its disposal infrastructure can handle, a trend that is projected to continue.

After recycling and composting, there are only two large-scale disposal options for New York's remaining waste: send it to landfills or convert it into energy. But many landfills in New York are at or near capacity. In fact, today New York exports 33% of its waste to other states due to a lack of available landfills. Recent landfill closures have exacerbated the disposal challenge. In December 2024, Ontario County voted to close its landfill, which will leave the county struggling to find affordable disposal options for 918,000 tons of waste every year. The most viable alternatives will almost certainly involve paying export fees and transporting waste long distances.

What's more, landfills emit methane, a greenhouse gas far more powerful than carbon dioxide – its warming potential is 84 times greater.¹ Landfills are the third-largest source of human-caused emissions in the U.S., according to the EPA.

Diverting waste from landfills and converting it into a renewable resource eliminates vast amounts of future greenhouse gas emissions. This is one of the reasons waste-to-energy is the EPA's preferred method for end-disposal of waste.



ABOUT TITLE V

The New York State Department of Environmental Conservation (NYSDEC) is charged with protecting human health by keeping the state's air quality as high as possible. To fulfill its mandate, the NYSDEC issues permits to commercial operators whose productions release emissions into the air. These permits allow NYSDEC to closely monitor the activities of these operators and ensure they are compliant with both the federal Clean Air Act standards and New York's own stringent Regulations for Air Emissions. Title V permits protect you and the environment.

Title V permits are on a five-year permit renewal schedule.







PERMISSIBLE EMISSIONS VS. ACTUAL EMISSIONS






















WASTE TYPES & ORIGINS

Most of the waste (89%) processed at Hudson Falls is post-recycled municipal solid waste – the types of things average households and businesses discard daily. A small percentage of the waste processed includes industrial waste such as biosolids, pharmaceuticals, and tires, which are acceptable materials under the facility's solid waste permit.

NYSDEC ensures that, regardless of what type of waste gets processed, the facility's emissions remain within its permitted limits. Permit compliance can assure the public that the plant is operating safely for both people and the environment.
